**TECUMSEH CHAPTER OF I.S.P.L.S.**  
**PROPOSAL FOR ANNUAL MEMBERSHIP DUES**

Charging of membership dues is not intended as an action to exclude anyone. Anyone, member or not, may attend any and all Tecumseh Chapter functions. The charging of membership dues is intended mainly as a means of raising funds for chapter functions, and should be viewed as a donation to the chapter rather than an admission fee. Chapter expenses are minimal; therefore, nearly 100% of our funds go towards providing scholarships to Purdue University land surveying students.

The chapter by-laws set forth by the I.S.P.L.S., that this chapter adopted, state that "voting members of the chapter shall be voting members in good standing in the I.S.P.L.S. and shall hold the same class of membership as they hold in I.S.P.L.S." i.e. if you are an Associate Member of I.S.P.L.S. you should be an Associate Member of the local chapter.

The following are the fees that are suggested:

**Member: \$50** Limited to Registered Land Surveyors, in good standing with the Indiana State Board of Registration for Land Surveyors. A Member shall be eligible to vote, hold office and to participate fully in the affairs of this chapter.

**Junior: \$40** Non-registered individuals who are endeavoring to make surveying their chosen career and are pursuing registration in Indiana. A Junior Member is entitled to vote and participate fully in the affairs of the chapter but shall not be entitled to hold office. At such time a Junior Member becomes registered their membership status will automatically be changed to Member.

**Associate: \$30** Anyone who is associated or affiliated with the Land Surveying Profession but is not otherwise pursuing registration, or any non-resident who is registered and in good standing as a Land Surveyor.

**Student: No Charge.** Student Members shall have the same eligibility requirements as those of a Junior Member, except that this class of Membership shall apply for a period of four (4) years only. A Student Member is not entitled to vote or hold office.

**Life: No Charge.** Life members shall have the same rights and privileges of a Member.
